

IZOTEM REFLEX P 4.5kg

Waterproofing membrane with a polyester carrier

Product description: IZOTEM REFLEX P 4.5kg is a waterproofing membrane made from a polyester reinforcement, that is coated on both sides with bitumen. The membrane is on the upper side protected by mineral granules and on the

bottom side by polimeric sheeting.

IZOTEM REFLEX P 4.5kg meets the demands of the standards EN 13969 type A. Characteristic of the product:

Use and installation:

IZOTEM REFLEX P 4.5kg, is used regarding the demands of the EN standards for less demanding one or more layered waterproofings of vertical or horizontal underground parts of objects, i.e. the resistance to ponding water. It can also be used as secondary roofing in systems of inclined roofs. The membrane is installed by torch or by gluing with 10cm overlaps.

Storage and transport:

The rolls have to be stored in an upright position, protected against dampness and extreme temperatures. In winter it is recommended to store the rolls before installation for 24 hours at a temperature of over +5°C.

The carrier is responsible for the correct transport.

Disposal considerations of waste:

For the removal of waste of product it is necessary to follow the valid local environmental regulations.



The product is in conformity with EN 13969:2004 and EN 13969:2004 /A1:2006 Type A.
